EXAM: The Level I exam will be given on **Saturday, May 20** from 10:00 a.m. – 12:00 noon at the Miramar Fire Rescue department.. In order to be eligible to take the exam, you must have completed all 40 hours of the Fundamentals of Code Enforcement classroom instruction.

The fee for the exam is **\$85.00** for F.A.C.E. members if payment is received by **May 5** and **\$120.00** thereafter. The exam fee for non-members is **\$135.00** and **\$170.00** for payments received after **May 5**.
